Sub: Implementation of new rates of NICSI's Operating Margin w.e.f. 01.07.2022

The Board of Directors in its 121st meeting held on 26.03.2022 and 122nd meeting held on 03.06.2022 has approved the new rates of NICSI's Operating Margin for all e-Governance/ICT projects being undertaken/to be undertaken by NICSI. The new rates of "Operating Margin" are as below.

S. NO.	Value of the project (Amount in Rs)	Rate of Operating Margin (in %)
1	Upto 50 Crores	9%
2	More than 50 Crores and upto 100 Crores	7%
3	More than 100 Crores	5%

2. NICSI will provide/refund the interest earned on the unspent amounts to the User Department(s) in all non-GIA projects, in which new rates of NICSI's Operating margin is applicable.

3. Above rates of Operating margin will be applicable w.e.f. 01.07.2022. However, all MoUs/Agreement/Contracts signed on or before 30.06.2022 would be honored as per the term & condition mentioned therein.

4. All existing Projects opened on or before 30.06.2022, the existing rate of Operating Margin will be applicable.

5. This Office Order supersedes the NICSI office Order No. 129/05-06/NICSI-CS dated 01.11.2017.
